## HILL & LEGAL HAPPENINGS: POLICY AND POLITICS

- TEMPS IN THE SENATE...NEW SENATOR TO BE SEATED SOON. New Jersey Governor Christie named Republican State Attorney General, Jeff Chiesa to fill the seat of the late Senator Frank Lautenberg until an October 16 special election. As a result, the Senate Democratic majority drops to 54-46. That's why the June 25 special election in Massachusetts is hot. John Kerry's Senate seat is being vied for by long-time Democratic Representative Ed Markey against newcomer, Republican Gabriel Gomez. Stay tuned!
- "No WAY" on MEDICAID CHANGES. At a hearing on the future of Medicaid, Democratic House Energy and Commerce members vowed opposition to Republican proposals to cap Medicaid spending by categories of beneficiaries, one of over 30 recommendations made in a 2011 National Republic Governors' Association report.
- PRESIDENTIAL VETO THREAT. The President has threatened to veto any appropriation measure that doesn't reflect a mix a mix of mandatory spending cuts and tax increases in lieu of current sequestration-imposed discretionary cuts. Yet, the House continues to work from the assumption that sequestration will remain in effect and has proposed increased military spending above the sequestration line on the back of discretionary programs. FY 2014 Labor, Health and Education appropriations by the House are targeted at 18% below the sequester. In contrast, the Senate is proceeding on the assumption the sequester cuts are dropped. Can you say "conference committee?"
